**All costs must be paid (no later than 3:00 p.m. on the day of sale) or the property will be resold at 3:00 p.m. to pay for costs.** Cancelled sales that had advertising and/or sheriff service must also be paid for. The Goshen News requires that each attorney firm prepay for advertising. Please provide us a valid email address so you may be notified of the required prepayment fees for advertising your sale. Failure to prepay fees by the deadline will result in the sale not being advertised and it will be cancelled. Your cooperation is appreciated.
